

KNOW YOUR RIGHTS IF ICE COMES TO YOUR DOOR



YOU HAVE THE RIGHT TO NOT OPEN YOUR DOOR

Don't open your doors. You have the right to refuse entry and ICE won't have consent to a search of your home.

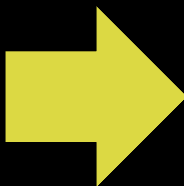


YOU HAVE THE RIGHT TO REMAIN SILENT

Ask the agents to identify themselves by having the badges to be presented to you by the window.

YOU HAVE THE RIGHT TO SPEAK TO A LAWYER

If they claim to have a warrant, ask them to slide a copy under the door or show it through the window. Only a federal judge grants ICE the legal right to enter your home;



I do not wish to speak with you, answer your questions or sign or hand you any documents based on my 5th Amendment rights under the United States Constitution.

I do not give you permission to enter my home based on my 4th amendment rights under the United States Constitution unless you have a warrant to enter, signed by a judge or magistrate with my name on it that you slide under the door.

I do not give you permission to search for any of my belongings based on my 4th Amendment rights

I choose to exercise my constitutional rights.

SHOW YOUR KNOW YOUR RIGHTS CARD

Most ICE warrants are administrative and do not allow forced entry.

If they do not have a judicial warrant, you can state clearly, "I do not consent to you entering my house"

TIENES DERECHO A NO ABRIR TU PUERTA

No abras tus puertas. Usted tiene derecho a rechazar la entrada y ICE no tendrá consentimiento para registrar su casa.

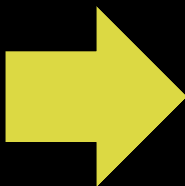


TIENES DERECHO A PERMANECER EN SILENCIO

Pídale a los agentes que se identifiquen haciendo que las insignias se le presenten junto a la ventana.

TIENES DERECHO A HABLAR CON UN ABOGADO

Si afirman tener una orden judicial, pídales que deslicen una copia debajo de la puerta o la muestren a través de la ventana. Sólo un juez federal otorga a ICE el derecho legal de ingresar a su hogar;

MUESTRA TU TARJETA CONOCE TUS DERECHOS

La mayoría de las órdenes ICE son administrativas y no permiten la entrada forzada.

Si no tienen orden judicial, puedes decir claramente: "No doy mi consentimiento para que entres a mi casa"
