

KNOW YOUR RIGHTS IF ICE COMES TO YOUR WORK



STAY CALM, DONT PANIC, DONT RUN AWAY

Stay calm and do not panic, calmly ask the officer if you are free to leave, if they say yes leave calmly, however, if they say no, stay where you are and do not attempt to run away

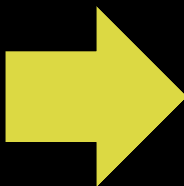


YOU HAVE THE RIGHT TO REMAIN SILENT

You do not have to answer any questions about your immigration status, or any information about you

YOU HAVE THE RIGHT TO SPEAK TO A LAWYER

If you are detained, you have the right to speak to a lawyer. If you do not have a lawyer you can still ask to speak to one



I do not wish to speak with you, answer your questions or sign or hand you any documents based on my 5th Amendment rights under the United States Constitution.

I do not give you permission to enter my home base on my 4th amendment rights under the United States Constitution unless you have a warrant to enter, signed by a judge or magistrate with my name on it that you slide under the door.

I do not give you permission to search for any of my belongings based on my 4th Amendment rights

I choose to exercise my constitutional rights.

SHOW YOUR KNOW YOUR RIGHTS CARD

Present your card to ICE, informing them you do not wish to speak or give them consent to search your belongings. FIEL will also be contacted and help you in the next steps

No abras tus puertas. Usted tiene derecho a rechazar la entrada y ICE no tendrá consentimiento para registrar su casa.

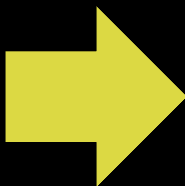


TIENES DERECHO A PERMANECER EN SILENCIO

Si está detenido, tiene derecho a hablar con un abogado. Si no tienes abogado aún puedes pedir hablar con uno
