

KNOW YOUR RIGHTS IF ICE PULLS YOU OVER



STAY CALM, DONT PANIC, DONT DRIVE AWAY

Pull over calmly, keep your hands visible, and stay calm. If asked, provide your driver's license and registration. ICE cannot search a car without a judicial warrant or the driver's or the owner's consent. If ICE searches your car anyway, you can still tell them that you dont consent.

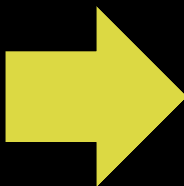


YOU HAVE THE RIGHT TO REMAIN SILENT

If asked about your immigration status, you have the right to remain silent do not lie about your immigration status or provide fake papers

YOU HAVE THE RIGHT TO SPEAK TO A LAWYER

If you are detained or arrested, you have the right to speak to a lawyer. If you do not have a lawyer you can still ask to speak to one



I do not wish to speak with you, answer your questions or sign or hand you any documents based on my 5th Amendment rights under the United States Constitution.

I do not give you permission to enter my home base on my 4th amendment rights under the United States Constitution unless you have a warrant to enter, signed by a judge or magistrate with my name on it that you slide under the door.

I do not give you permission to search for any of my belongings based on my 4th Amendment rights

I choose to exercise my constitutional rights.

SHOW YOUR KNOW YOUR RIGHTS CARD

Present your card to ICE, informing them you do not wish to speak or give them consent to search your belongings. FIEL will also be contacted and help you in the next steps

MANTÉN LA CALMA, NO ENTRES EN PÁNICO, NO TE ALEJES

Deténgase con calma, mantenga las manos visibles y mantenga la calma. Si se le solicita, proporcione su licencia de conducir y registro. ICE no puede registrar un automóvil sin una orden judicial o el consentimiento del conductor o del propietario. Si ICE registra tu auto de todos modos, aún puedes decirles que no das tu consentimiento.

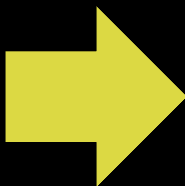


TIENES DERECHO A PERMANECER EN SILENCIO

Si se le pregunta sobre su estatus migratorio, tiene derecho a permanecer en silencio, no mentir sobre su estatus migratorio ni proporcionar documentos falsos

TIENES DERECHO A HABLAR CON UN ABOGADO

Si está detenido o arrestado, tiene derecho a hablar con un abogado. Si no tienes abogado aún puedes pedir hablar con uno
